



Qualifications & Instructions for 2014

The Pennsylvania Harness Horsemen's Association (PHHA) will annually grant college scholarships as follows:

Eligibility: The candidate must be a son or daughter of an owner, trainer or driver who has participated in harness racing in the State of Pennsylvania on a regular basis over the two (2) years preceding application. Said parent must be a member of the PHHA. Children of deceased members are also eligible. Previous winners are encouraged to re-apply provided they have not reached the lifetime benefit amount of \$10,000.

Educational requirements: The candidate must be a senior at any public or private secondary school or a previous high school graduate. He or she should take either the SAT or ACT test and must be recommendable to a college or university by his or her secondary school.

Financial need: The financial need of the candidate will be considered and estimated on the basis of his or her parents' annual income, assets and any special family circumstances. In assessing need, the number, ages and schooling needs of brothers and sisters will be taken into account.

Extra-curricular and community service participation: The extent to which a candidate has participated in and contributed to the life and welfare of school and/or community will be taken into account in the assessment of merit.

Standards of consideration: An applicant for this scholarship will be judged by criteria that, in addition to those listed above, include scholarship, citizenship, and leadership. Evidence of character and personality is sought and will be reviewed with care. Enrollment in a curriculum related to the harness racing industry will receive special consideration.

Application for Consideration

Applications for consideration will be available at all PHHA member association offices and online. To advance properly the interest of the applicant and to conserve the time of the committee, all materials presented should be orderly, concise and chronological. All letters should be removed from envelopes and bound flat for review. Exhibits evidencing notable achievements in leadership, literature, athletics, dramatics, community service or other activities may be attached, but the applicant should avoid repetitious accounts.

Applications must include the following (in the order indicated):

1. Two letters of recommendation, neither over 200 words, one from a school official and one from a member of the community.
2. A transcript which shows the most recent rank in class and the scores obtained on a national test, either the College Entrance Examination Board Scholastic Test (SAT) or the

American College Testing Program (ACT) or the Canadian equivalent.

3. A recent black and white, wallet size photo of the applicant.

Applications that do not conform substantially to the foregoing requirements will not be considered. However, in the event that a candidate's academic achievements are not reflected by grades and tests, other attributes must be provided.

Filing of Applications

The application, signed by the principal or dean of the applicant's school and properly certified by the association, must be filed before September 15, 2014 at:

Subsequent application, which is a qualifying academic grade point average, must be submitted to the Trustees prior to receiving payments.

Additional Conditions

The PHHA, through this program, seeks students of outstanding merit who show an appreciation of the value of an education and who are willing to achieve success. It is noted that the student must remain a full-time student and maintain a minimum 2.0 cumulative grade point average in the year he or she receives the scholarship. If for reasons of health or other emergencies the student does not remain enrolled full time, he/she must receive approval from the Trustees to qualify for subsequent scholarship payments. As a condition precedent in awarding the scholarship, the PHHA Board of Trustees reserves unto itself the right to cancel or otherwise terminate a grant at any time an awardee, in the opinion of the Trustees, directly or indirectly engages in undesirable activities.

The number of recipients and dollar amount of the scholarships shall be decided yearly by the PHHA, but said scholarship shall be in the minimum amount of one thousand dollars (\$1,000) per student. The recipient of the scholarship shall be eligible for consideration for said scholarship in subsequent years provided they have not reached the lifetime maximum benefit of \$10,000.

The scholarship will be paid to the college or university by the PHHA on behalf of the student. The applicants will be judged by educators chosen by the Trustees of the PHHA, not affiliated with any horsemen's association, racetrack or the PHHA. Those rules are subject to change by the Board of Trustees from time to time.
